Mrs Theresa Ezzama Member representing Yahe Ward, Mr Johnson Ogri Member representing Yache Ward, Late Hon. Augustine Ilom Member representing Wanokom Ward, Hon Emma Lifu Member representing Ugaga Ward and Chief Henry Onwe Secretary/member representing Mfuma/Ntrigom Ward which came up with formula for distributing the Chairmanship position among the five blocs in the local government area.

The zoning formula adopted splited Yala Local Government Area into five blocs as follows; North Ukelle; Wanihem, Wanikade, Wanokom, and Igede wards, South Ukelle; Mfuma Ntrigom and Ijiraga wards, Western Yala; Yahe, Okpoma, and O'oh wards and Eastern Yala; Echumofana, Okuku, Ugaga wards and Yache and Gabu wards as one bloc.

In view of the fact that That the entire caucus in 2010 agreed that position of Chairman of Yala should be held on a rotational basis among the 5 blocs, and in lieu of the fact that the last Chairman of Yala of Ukelle extraction was from north ukelle block, THE GROUP HAS ZONED THE CHAIRMANSHIP POSITION TO SOUTH UKELLE AND THEREFORE REQUEST ALL POLITICAL PARTIES PARTICIPATING IN THE FORTH COMING LOCAL GOVERNMENT ELECTION TO ENSURE THEIR CANDIDATES ARE PICKED FROM THE 2 WARDS IN SOUTH UKELLE.
